Course Description

This course attempts to give an introductory account of time series models and their application to modelling and prediction of data collected sequentially in time. The aim is to provide specific techniques for handling data and at the same time to provide some understanding of the theoretical basis for the techniques. Topics covered will include univariate linear and non linear models (both in mean and variance) and some basics of spectral analysis.

Objectives

The objectives of this course are:

- to introduce the students to the main developments in time series analysis;
- to learn theoretical, applied and computational methods for time series analysis and forecasting;
- to gain experience in model building;

- Linear time series models: parameter estimation and forecasting.
- Transfer function models
- Introduction to spectral analysis.
- Nonlinear models: an introduction.
- Nonlinear models: Markov-Switching Models and Threshold Autoregression Models.
- Nonlinear models: ARCH-type models
- Long-memory models. Integer AutoRegressive models.
